ORDER DUE TO EXIGENT CIRCUMSTANCES

Acting under the authority of Article V, Section 1 of the Louisiana Constitution of 1974, the inherent power of this Court, and considering the recent outbreak of the Coronavirus-19, Governor John Bel Edwards's Declaration of a Public Health Emergency and his ongoing State Proclamations, President Donald J. Trump's Declaration of a National Emergency, the Orders of the Louisiana Supreme Court, and in consideration of public health recommendations to reduce the risk of exposure to the virus and to assist in slowing the spread of the disease:

IT IS ORDERED that Normal Operation of the Winnfield City Clerk to the Public is suspended from the date of this order at noon until April 13, 2020. If you have filings to make, in accord with Louisiana Revised Statutes 13:850 you can fax the filings to 866-521-0572 and/or mail them to

IT IS FURTHER ORDERED that if it is necessary to come to the Court facilities, you should call the Court first to schedule an appropriate time for your visit. To the extent possible, all business with the Court should be handled by phone - 318-628-4844, or mail, or email.

IT IS FURTHER ORDERED that any and all Civil Trials set between now and April 13, 2020, are continued and will be reset by order of the court.

IT IS FURTHER ORDERED AND RECOGNIZED that all Civil Time delays and calculations are determined by the Proclamations of the Governor and Legislation.

IT IS FURTHER ORDERED that all Criminal Proceedings or Traffic Violation/Citation Proceedings that would normally require the presence of a defendant that are set for April 2, 2020, are hereby continued and are reset to June 4, 2020. Notice will be sent to the last known address also. If you have changed your mailing address, please notify the court by phone, mail, or email.

IT IS FURTHER ORDERED that the delays in all Criminal/Traffic cases created by this Order shall constitute "just cause", pursuant to Louisiana Code of Criminal Procedure Article 701.

IT IS FURTHER ORDERED that most traffic tickets can be paid online at quickcourt.biz and selecting the Winnfield City Court. Or traffic fines may be paid by money order or cashier's check payable to Winnfield City Court, P.O. Box 1342, Winnfield, LA 71483.


IT IS FURTHER ORDERED that this Order does not affect the Court's ability to consider Civil or Criminal Matters that can be resolved without a hearing.

IT IS FURTHER ORDERED that all Court Proceedings and Normal Operations of the Winnfield City Clerk will re-open to the public on April 13, 2020, unless that date is extended by further Orders of this Court or the Louisiana Supreme Court.

IT IS FURTHER ORDERED that all Normal Criminal Processing of Arrests will be continued via telephone conferences, as per custom of the court.

IT IS FURTHER ORDERED that this Order is effective as of noon, March 19, 2020, and shall remain in effect until April 13, 2020, unless modified by Order of this Court or the Supreme Court of Louisiana.
