AMENDED ORDER


Considering the impact of the recent threats to public health arising from the spread of the COVID-19 virus worldwide, and in particular, in Louisiana and the Lafourche Parish area, and in order to protect the citizens of Lafourche Parish, as well as employees and staffs of the 17th Judicial District Court and the Clerk of Court's office,

And in light of the Declaration of Emergency issued by the Governor of the State of Louisiana (Proclamation 25-JBE-2020 and amended 27-JBE-2020), and with guidance from the recommendations of the Louisiana Supreme Court issued on March 16, 2020 that courts "restrict court settings to emergencies and time sensitive settings," the following shall apply to all court matters set from March 20, 2020 through March 27, 2020,

IT IS ORDERED that all civil, criminal and juveniles matters involving citizens who are not incarcerated are continued with notice to be issued to the litigants, except civil protective orders, child in need of care proceedings, emergency child custody matters, proceedings for children removed from their home by emergency court order, proceedings related to emergency interdictions and mental health orders, matters of public health related to this crisis and other emergency matters necessary to protect the health, safety and liberty of individuals as determined by each court.

IT IS FURTHER ORDERED that matters involving incarcerated individuals including magistrate appearances, bond hearings and arraignments shall be conducted by simultaneous audio-visual conference with the jail in Division C.


