PUBLIC HEALTH EMERGENCY


Acting under the authority of Article V, Section 1 of the Constitution of 1974, and the inherent power of this Court, and considering the COVID-19 public health emergency, the State of Emergency declaration issued by Governor John Bel Edwards (Proclamation 25-JBE-2020, amended 27-JBE-2020 and amended 33-JBE-2020) the recommendations issued on March 12, 2020 and March 23, 2020 by the Louisiana Supreme Court and the emergency declaration by Lafourche Parish President Archie Chiasson on March 13, 2020, the 17th Judicial District Court, Parish of Lafourche issues the following Order:

In consideration of the public health recommendations and in order to protect the citizens of Lafourche Parish as well as employees of the Lafourche Parish Clerk of Court and to reduce the risk of exposure to the virus and slowing the spread of the disease while balancing the need to maintain access to Louisiana court,

All public access to the Lafourche Parish Clerk of Court Offices is suspended during this public health emergency. The Lafourche Parish Clerk of Court office will be open from 8:30 a.m. to 1:00 p.m. Monday through Friday commencing March 23, 2020 through March 27, 2020 during which the Clerk of Court will continue to accept all filings in accordance with Louisiana Law. For information regarding emergency filings between 1:00 p.m. and 4:30 p.m., please call (985)387-5358.

Considering the reasons stated, the foregoing Emergency Closure Order is agreed to and confirmed, in accordance with law.


