<b>Rule - 14.0</b>	The Clerk of Court shall randomly allot all felony, misdemeanor cases and wildlife offenses between the three divisions at the time of the filing of the Bill of Indictment, Bill of Information or at the time the matter comes before the Court with the filing of a Motion pursuant to Rule 14.2, whichever occurs first. (See Rule 14.2 regarding assignment of cases when particular motions are filed prior to allotment as set forth above.)
<b>Appendix - 14.0A</b>	
System of Random Allotment of Criminal Cases (Other than Traffic, Wildlife, and Appeals from Lower Courts)	Method of Allotment of Criminal Cases: Criminal cases shall be randomly allotted to the different divisions of the court in the following manner: Three (3) balls of equal size and consistency shall be placed in a container with one (1) of said balls designated as Division A, one (1) as Division B, and one (1) as Division C. The container should be of an opaque nature so that the contents may not be seen. When a case is to be allotted, the contents of the case should be thoroughly mixed and a ball drawn from the container. The case is then allotted to the Judge whose division is represented by the letter on the ball drawn. The ball so drawn shall be returned to the container with the other balls and the process repeated for further allotments.
Amended effective January 3, 2018.	The allotment of criminal cases may also be made by random assignment through a computerized software system.
	Upon the consent of all parties and the Judge before whom he appears, a defendant in a misdemeanor case or wildlife offense may plead guilty or nolo contendere before any Judge of any division and may be sentenced by that Judge.
	The judge of any division may accept a not guilty plea in any felony, misdemeanor case or wildlife offense.
