PUBLIC STATEMENT

Every candidate for judicial office in Louisiana must campaign in accordance with the precepts contained in Canon 7 of the Louisiana Code of Judicial Conduct. The Louisiana Judicial Campaign Oversight Committee (“the Committee”) is authorized by the Louisiana Supreme Court to review and investigate complaints, which allege violations of certain provisions of Canon 7. Although Committee deliberations are and remain confidential, once a public statement has been issued or a complaint has been dismissed, the complaint and response are matters of public record and may be requested through the Court’s Community Relations division.

The Committee has received a complaint which alleges that Marie Williams, a candidate for Orleans Parish Civil Court, Division E violated Canon 7A(9) of the Louisiana Code of Judicial Conduct. Canon 7A(9) provides that a judge or judicial candidate shall not “knowingly make, or cause to be made, a false statement concerning the identity, qualifications, present position, or other fact concerning the candidate or an opponent.”

The complaint concerns several statements posted by Marie Williams on Facebook, which claim that Voice of the Experienced (“VOTE”) and the Power Coalition for Equity and Justice held a public candidate forum and “purposefully” did not invite Ms. Williams, and instead invited only her opponent. A copy of Ms. Williams’ Facebook posting is attached. VOTE appears to have made several attempts to invite Ms. Williams. A copy of the email invitations are attached.

The Committee, therefore, believes that these statements posted by Ms. Williams on Facebook violate Canon 7A(9), that a or judicial candidate shall not “knowingly make, or cause to be made, a false statement concerning the identity, qualifications, present position, or other fact concerning the candidate or an opponent.”

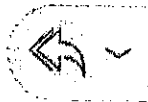

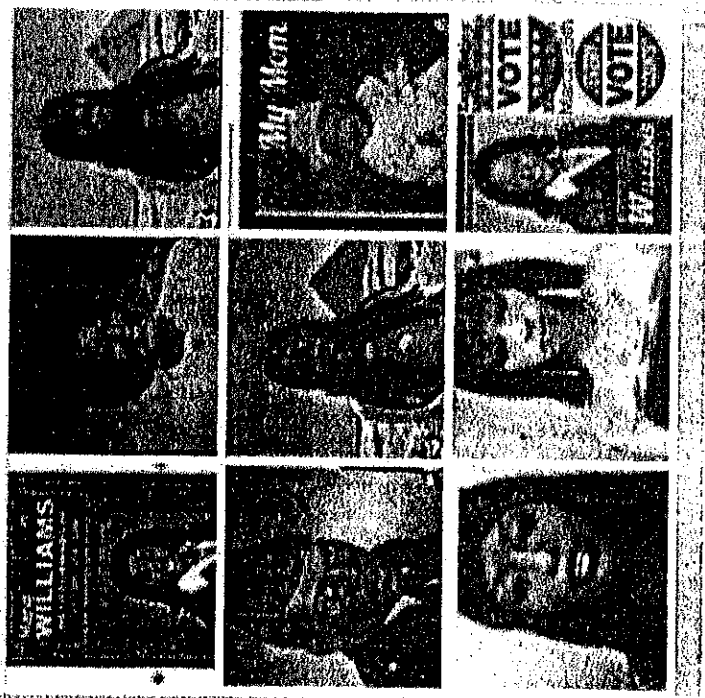

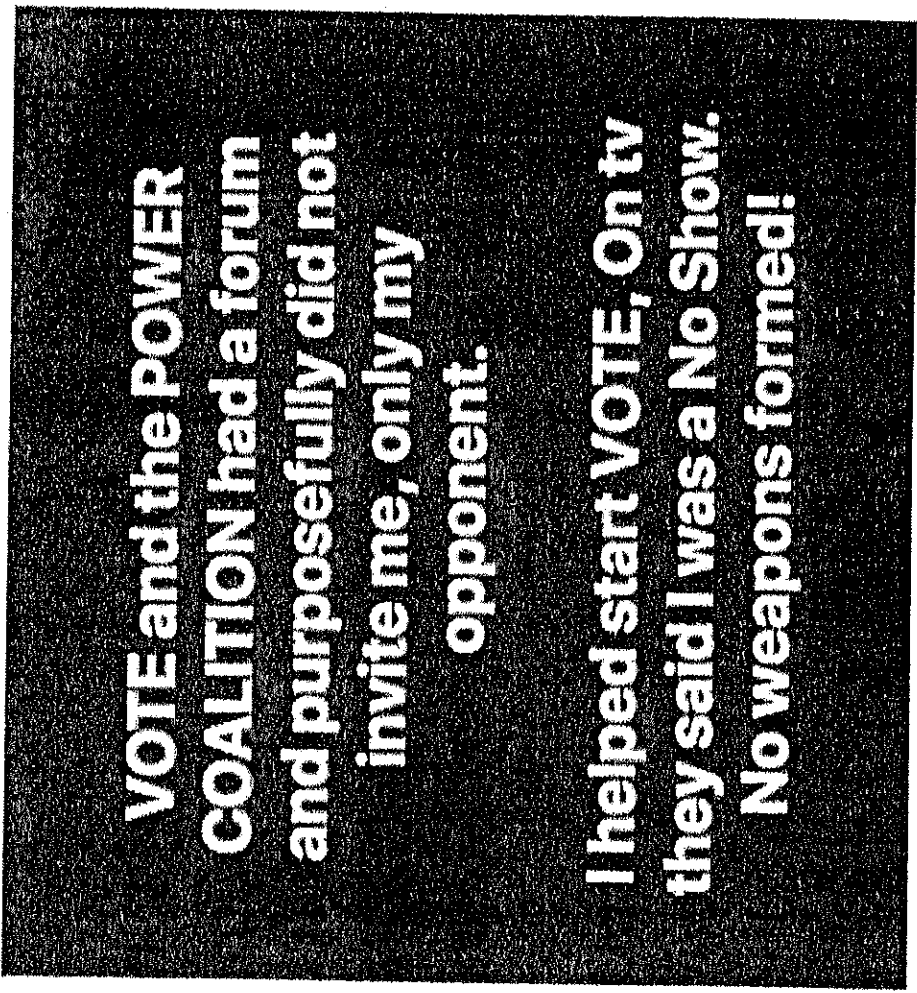

Our one and only public statement regarding the accusations made against us and our partners at VOTE by judicial candidate Attorney Marie Williams.

The Power Coalition for Equity and Justice is a non partisan organization committed to amplifying the voices of the underserved in Louisiana and supporting public policies that uplift and empower Louisiana families. Our mission is to inform voters by providing opportunities for them to meet candidates, ask questions, and decide for themselves who should best serve our community. As a non partisan organization, it is our duty to offer invitations to all candidates, regardless of affiliation. Attorney Marie Williams, a candidate for Orleans Parish Civil District Court Judge, was invited on two occasions by email, followed by multiple phone calls to participate in a candidate forum hosted by us in partnership with VOTE held on Wednesday, November 14th. After twice sending an invitation to the email she personally provided in response to a candidate survey conducted by VOTE, no response was received from Attorney Williams or her camp. The emails were followed up with several phone calls made by VOTE and StepUp Louisiana to Attorney Williams. Again, no response was ever received from Attorney Williams or her camp. It is unfortunate that Attorney Williams was unresponsive to our attempts to have her attend. It is also unfortunate that Attorney Williams chose to express her displeasure on multiple social media platforms without contacting either organization directly. However, we hope that when offered the opportunity in the future, she participates. We are committed to creating open spaces for the community to engage with all candidates. We gain nothing by silencing anyone's voice.
