PER CURIAM* ** *** ON REHEARING

Plaintiffs/Respondents' Application for Rehearing is granted in part, solely for the purpose of correcting footnote 9 in the original opinion to read as follows:

The trial court also awarded the plaintiffs attorney fees, expert witness fees and costs, assessing seventy-five percent (75%) of these fees and costs against the State pursuant to La. R.S. 13:5111(A), and assessing twenty-five percent (25%) of the fees and costs against the common fund pursuant to La. Code Civ. P. art. 595. The court of appeal amended the trial court's judgment to assess one hundred percent (100%) of these awards against the common fund. *Crooks v. Department of Natural Resources*, 2017-750, p. 35-38 (La. App. 3 Cir. 12/28/18), 263 So. 3d 540, 565-67 (Amy, J., dissents). The award for those items is not at issue in this writ application.

In all other respects, Plaintiffs/Respondents' Application for Rehearing is denied.

The Application for Rehearing filed by Defendant/Applicant, the State of Louisiana, through the Louisiana Department of Natural Resources, is denied.
