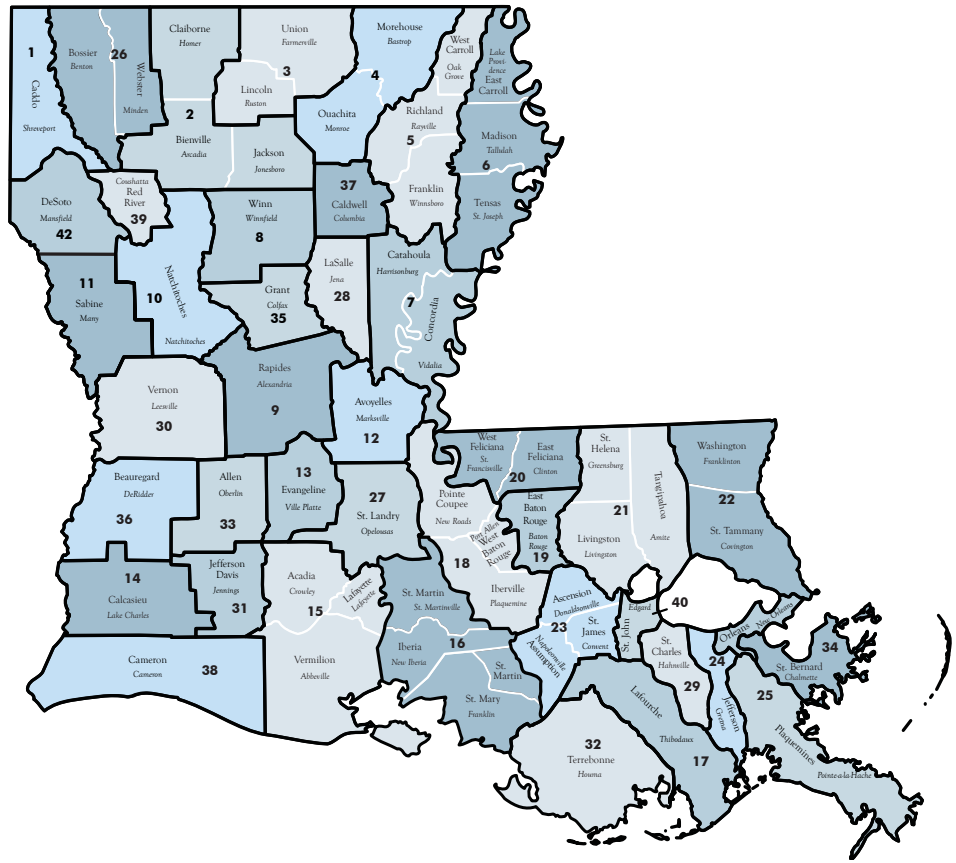

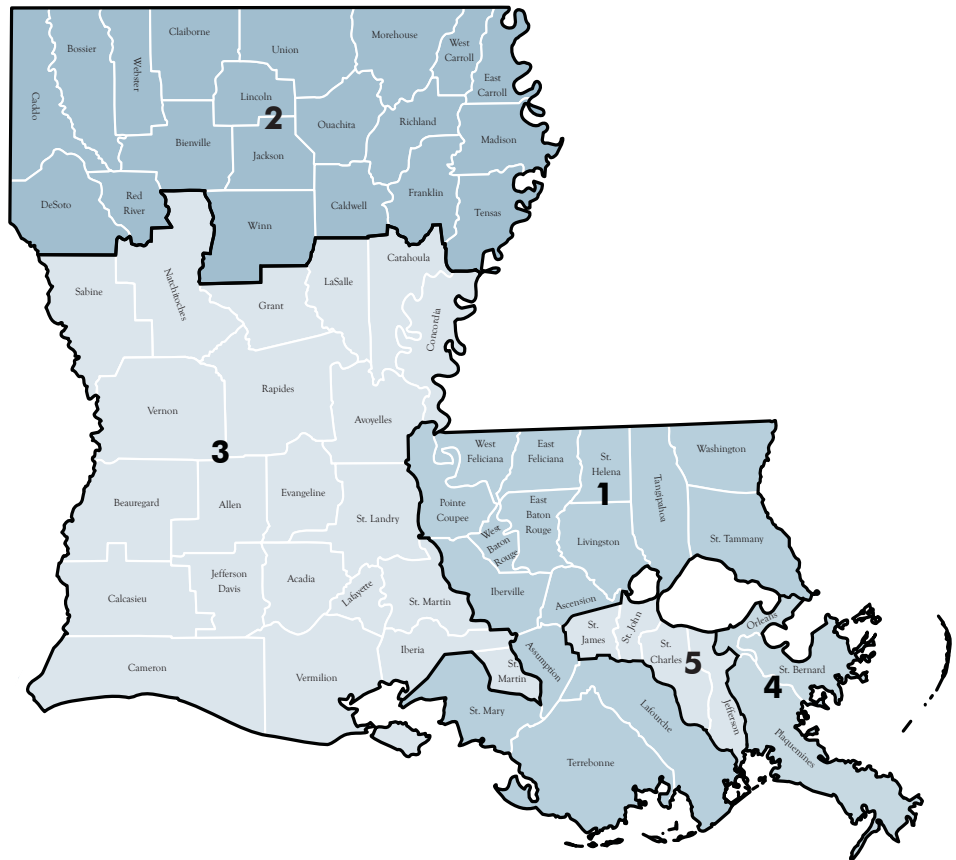
## LOUISIANA DISTRICT COURTS JUDICIAL DISTRICTS

\* ACT 621 of 2006 Regular Legislative Session reorganizes and consolidates the Orleans Parish civil and criminal courts to 41<sup>st</sup> Judicial District Court by January 1, 2010; consolidates civil and criminal sheriffs by January 1, 2010; consolidates Orleans Parish civil, criminal, juvenile, 1<sup>st</sup> City and 2<sup>nd</sup> City Courts judicial expense funds by January 1, 2009; abolishes the recorder of mortgages, register of conveyances and notarial archives by January 1, 2009, and merges those offices with the Clerk of Civil District Court until the Clerk of the 41<sup>st</sup> Judicial District Court is created January 1, 2010; consolidates Orleans Parish Juvenile Court with the 41<sup>st</sup> Judicial District Court effective January 1, 2015. ACT 873 of the 2007 Regular Legislative Session amends ACT 621 to change the effective date of January 1, 2010 to be December 31, 2014.

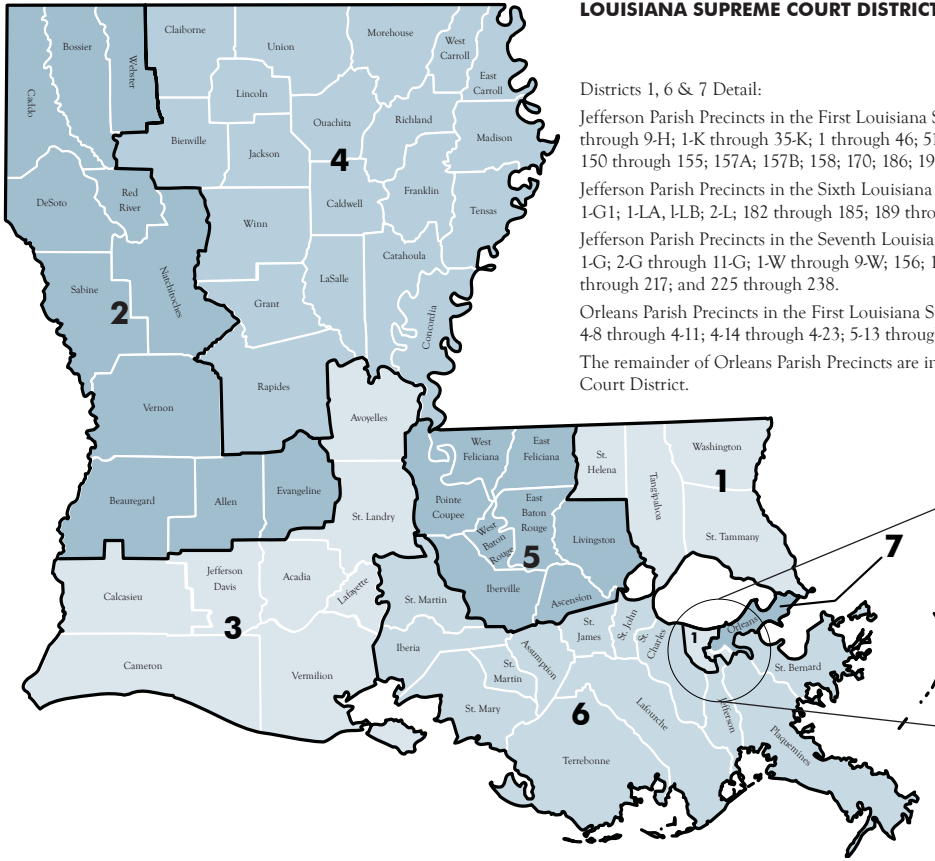
\*\* ACT 416 of 2007 Regular Legislative Session splits the 11<sup>th</sup> Judicial District Court to create a new judicial district comprised of DeSoto Parish as the 42<sup>nd</sup> Judicial District.

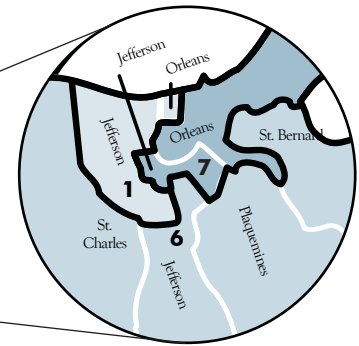

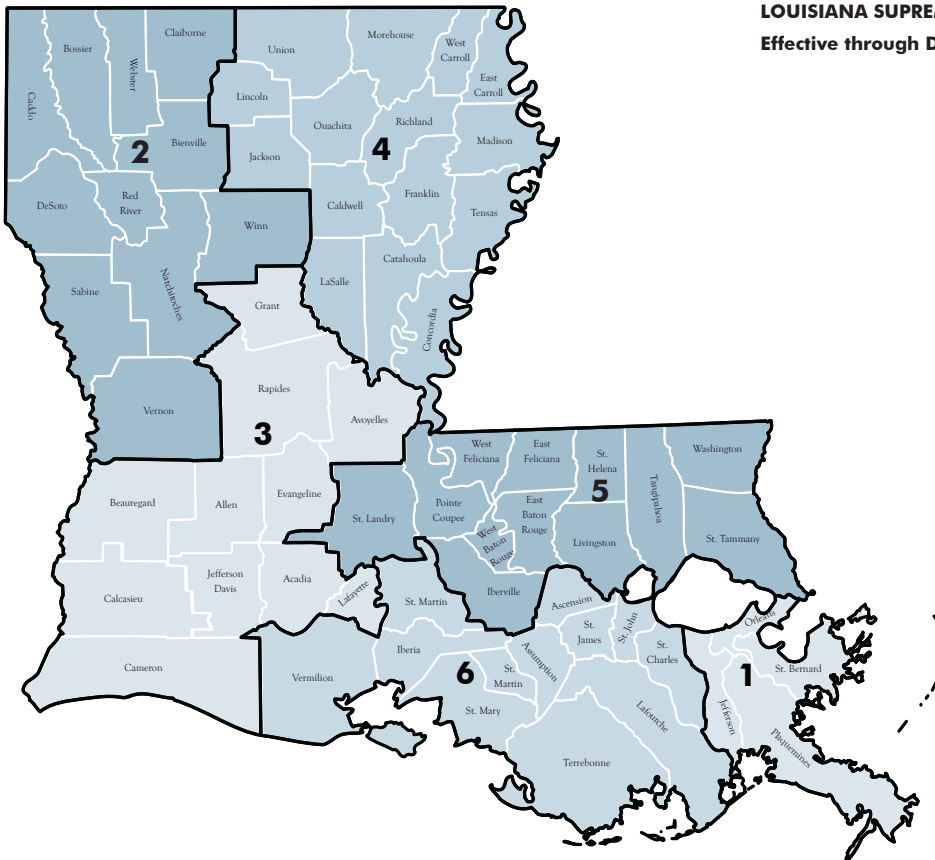
Jefferson Parish Precincts in the Seventh Louisiana Supreme Court District are 1-G; 2-G through 11-G; 1-W through 9-W; 156; 171 through 181; 187; 188; 210 through 217; and 225 through 238.

Orleans Parish Precincts in the First Louisiana Supreme Court District are 3-20; 4-8 through 4-11; 4-14 through 4-23; 5-13 through 5-18; and 17-17 through 17-21.

The remainder of Orleans Parish Precincts are in the Seventh Louisiana Supreme Court District.

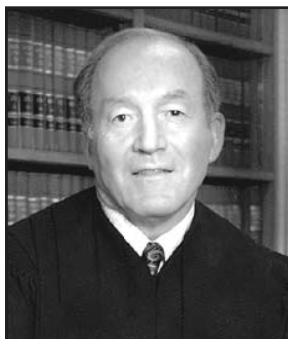
